

# Toledo Area Western Dance Leaders Association

## Minutes of October 12, 2014

The October 12, 2014 meeting of the Toledo Area Western Dance Leaders Association was called to order by President Dan Beck at 2:02 p.m. at Foxgate Farms Clubhouse, Bowling Green, Ohio. No Workshops were presented.

- Turkey Foot Trotters/Fountain City Squares: Eight new dancers are in this class plus one couple of returning dancers.
- Norwalk F.A.D.S.: Dan Beck reported there are 8-10 new dancers and that last year's new dancers are back as angels. He also reported that Mansfield has 26-28 dancers in class – about 9 squares.
- Tiffin T-Squares: This club reported 8 new dancers this year, 6 single women and 1 couple.

**State Corp:** No report for this month.

Dan Beck reported that the American Callers Association and Callerlab have finally agreed on a smaller teaching list. He also reported that he is doing workshops at clubs a couple times a month to assist dancers with teaching reinforcement.
